

## SHIFNAL TOWN COUNCIL

Minutes of the Planning Committee Meeting Held on Thursday 10<sup>th</sup> February 2022, commencing at 2.30pm At The Old Police Station, Tudor Way, Shifnal, TF11 8DJ.

Presentation from Andy Wigley (Shropshire Council Historic Buildings) and Terry Alexander (Shropshire Council Public Protection) on Empty Home, Shifnal

Cllr Tarran welcomed and introduced the presentation by the officers. Andy Wigley and Terry Alexander answered questions from Councillors and members of the public on 22 Market Place and empty homes in Shifnal. Andy Wigley advised that enforcement action under S215 of the Planning Act was prepared and waiting legal clearance to issue. The Notice will require improvement works to the exterior of the building and enable the security fencing to be removed. He is liaising with Highways so that the timescale for the works relates to the completion of SITS.

Terry Alexander advised that empty homes powers were discretionary and depended on assessing financial and resource implications. Shropshire Council were producing an Empty Homes Strategy later in the year which would go out for public consultation. Shropshire Council would then review their actions on individual properties in the light of the decisions in the strategy. He confirmed that no action was at present being taken with regard to the specific properties referred to by the Town Council.

#### P314/21 Public Session

Gerald Nickless raised concern at the response from the Shropshire Council Officers on 22 Market Place and that their comments gave him no assurance that action would be taken quickly.

Kath Hemsley expressed disappointment in the Shropshire Council Officers responses and that other Councils were more responsive in taking action. Tony Jemmett referred to the continued deterioration in the condition of 22 Market Place with materials starting to fall off. He also raised concern at the safety of 16-18 Market Place which, in his opinion, may be due to inadequate foundations and HGV traffic causing vibrations. He considered that Shropshire Council needed to look at stopping such traffic through the town.

  - b) to write to the Leader of Shropshire Council expressing concern at the delays in taking formal action,
  - c) to seek to publicise the Town Council's and local residents concerns at the delays through the Shropshire Star.
- ii) In respect of Empty Homes in the town it was agreed that
  - a) Cllr Williamson to contact Terry Alexander of Shropshire Council in respect of 36 Stafford Avenue,
  - b) to write to the Leader of Shropshire Council expressing concern at the lack of action in bringing empty homes back into occupation,
  - c) to seek to publicise the Town Council's concerns at the inaction of Shropshire Council in dealing with long standing empty homes in the town through the Shropshire Star.
- iii) In respect of concerns over the condition of 16-18 Market Place it was agreed to
  - a) write to Shropshire Council Building Control Section asking them to investigate the safety of the building,
  - b) submit a planning enforcement complaint seeking Shropshire Council to take listed building enforcement action to ensure the proper preservation of the building.
