Recommend that Full Council approve Brewood Landscapes Ltd be appointed for the green space contract from the 1st April 2022 to 31st March 2023 at a cost of £22,360.00 (+VAT) from the budget line: 31: Open Space Maintenance (Local Government (MP) Act 1976 s. 19 (3))
