Presentation from Tracy Darke (Asst Director for Economy and Place) and Steve Smith (Assistant Director for Infrastructure)

Tracy Darke attended in person to the meeting and Steve Smith attended via online format.

Both gave an insight into the progress being made by Shropshire Council with the legacy backlog of cases in planning enforcement, planning and economic policy document updates and infrastructure delivery.

New staff are being recruited and trained and delivery structures are being altered with an aim to be able to communicate with clarity to stakeholders and public about the realistic timescales for delivery of long awaited outcomes.

The aim is to prioritise the projects that are urgent or have most impact on the local area.

The officers noted the concerns raised regarding the delivery of infrastructure projects around the new Haughton Road development and other S106 funded schemes in the town. They both agreed to take away the members comments, investigate and feedback with realistic delivery aims as soon as possible to the Town Clerk. Steve Smith left the meeting at 15.09 hrs

Tracy Darke continued to update on the developments in IT systems to allow increased access and information to parish council on planning enforcement matters. She advised members that refusal of a retrospective planning application may not lead to enforcement due to complex planning regulations.

She further updated on the specific powers being utilised in regards to 22 Market Place. A copy of enforcement notices to be forwarded to the Town Clerk.

The Chairman thanked both Tracy Darke and Steve Smith for their attendance and look forward to receiving updates and actions in due course.

Tracy Darke and Cllr John Moore left the meeting at 15.27 hrs.
