- iii) To recommend Council note, subject to the above proposal, the continued appointment of Bruton Knowles as consultant representative for the remainder of the Shropshire Local Plan process. APPROVED
- iv) To recommend Council confirm that the members of the Planning Committee have the ability to advise Bruton Knowles as required on matters already agreed by Shifnal Town Council. APPROVED
