Moore discussed the update received from Mr T. Jemmett in regards to Bruton Knowles and the programme of the examination. Members noted Mr Jemmett's comments and agreed for the Town Clerk to address the following questions direct to Bruton Knowles for confirmation.

P452/21 To consider a verbal update on the Empty Homes situation in Shifnal.

A response had been received from Cllr Lezley Picton in regards to the letter sent on this matter. Members considered the contents of the letter and it was NOTED. Members further agreed to issue a press statement detailing the six months notice period that had been issued in regard to rectification works at 22 Market Place and to review the outcomes at the end of this period. APPROVED

Cllr Williamson will continue to press on the conflicting impact on the town centre works. ACTION

Cllr Tarran to progress the press release with Cllr Turner. ACTION Members agreed to review all other empty homes after the relevant strategy had been completed by Shropshire Council. ACTION

All enforcement notices had confirmed receipt and SALC were pressing for parishes to receive better communications on enforcement cases once opened. Members agreed to review 16-18 Market Place at the May meeting. ACTION

P453/21 To CONSIDER verbal update on the Place Plan

It was NOTED that the Place Plan is an important evidence base to inform the Local Plan by Shropshire Council and that E West had suggested that there was an expectation of a full review of the Place Plans later in 2022.

No appointment date had yet been forthcoming for the review process to start with Shropshire Council officers. Town Clerk to chase Place Plan officer on this matter in view of the above. ACTION

Cllrs P. Williamson and T. Tarran had met with Shropshire Cllr K. Turley and G. Lawley and notes of the meeting had been circulated.

Darke, Asst Director for Economic Growth and Planning and A. Wilde, Head of Highways to the June committee meeting. ACTION
