Cllr Tarran advised that he had attended a meeting with Bruton Knowles, Tong Parish Council and Shifnal Matters 2021.

It was agreed at this meeting that Bruton Knowles would be presenting on all matters on behalf of the Council in Stage 1 of the public examination.

Anyone is able to attend to observe but a Council member may be required at some points to act as advisor to Bruton Knowles as they present.

Bruton Knowles are working through extensive amounts of new documentation to draft the hearing statements and have indicated they should be available within the next week.

Members discussed the difficulties that had been encountered by the significantly short timescales for preparing such statements and actions that have or may be brought forward to try and improve the situation.

The initial indicated costs of the Bruton Knowles for preparations and attendance at the stage 1 hearings were NOTED to be within the allocated budget.

P519/21 To consider a verbal update on the Empty Homes situation in Shifnal.

It was NOTED that no further actions could be brought forward until the 6 month notice period had expired.

All actions previously agreed had been completed.

P520/21 To CONSIDER verbal update on the Place Plan

The Town Clerk updated that a meeting had been held with the Place Plan officer for Shifnal and a new portal system of review was detailed. This would allow all parties including the Town Council to update and review items identified for inclusion on the place plan.

Shropshire Council will be submitting the statutory and strategic projects and the Town and Parish councils will then be invited to add any locally identified projects. All projects will be expected to be detailed to include evidence of need and community support, funding streams and estimated budget. The timescale for Councils' review will be Sept/Oct 2022.

The Shropshire Economic Growth Strategy is being drafted this year and once completed this council will be invited to complete an Economic Growth Strategy for Shifnal. This is likely to start late summer. In the meantime links will be signposted for town regeneration help and support.

Cllr Tarran identified a document that detailed infrastructure needs within Shifnal that had been provided for the Local Plan evidence base. He further detailed items within the document. The document gc4t Shropshire Strategic Infrastructure and Investment Plan 2022 can be found as an appendix to these minutes.
