## 297/22 To CONSIDER delivery of the Christmas Lights Switch On Event 2022

- Delegation of expenditure powers to Council Officers in conjunction with the Mayor were CONSIDERED.
  - Cllr T. Tarran advised that delegation of expenditure powers under Section 101 of the Local Government Act 1972 should be to a named Officer only.
  - Cll R. Cox proposal to change the wording to delegate expenditure powers to the Administration Officer, Helen Howse, in consultation with the Mayor was APPROVED.
  - The delegation of expenditure powers to the Administration Officer, Helen Howse, in consultation with the Mayor up to the £35,751.99 agreed budget for 2022/2023 was APPROVED.
- (ii) Virement of up to £14,248.01 (if required) from General Reserves to the Christmas Lights budget to provide the Christmas lights display and switch on event 2022 was CONSIDERED.
  - Cllr J. Moore proposed to defer the decision on the suggested virement until
    the Town Clerk's return from leave and come back to council with a more
