### 185/19 Town Clerk Report

 To CONSIDER proposals to engage in the Police and Crime Commissioners Budget Setting Consultation – Cllr Tim Day;

Councillor Day advised a 50p per month or £1 per month increase on the Precept of Shifnal residents in order to increase visible Policing in the West Mercia area might be beneficial. Cllr Bird requested a report to show that Police numbers in the West Mercia region have been increasing and this effect on the crime statistics.

The Town Clerk read a Press Release from the Police Crime Commissioner regarding an online consultation with members of the public on 20 January 2020.

Cllr Killen reported that residents had requested to her that future Police Surgeries take place at the weekend or in the evenings as it was not always possible for them to attend during the day.

Cllr Day proposal was CONSIDERED with an Amendment from Cllr Trickett. To engage in the Police and Crime Commissoiners Budget Setting Consultation with a view to continue to explore improved efficiencies and value for money. ACCEPTED.

ii) To CONSIDER proposals regarding the siting of a Remembrance Bench in Shifnal:

Councillors AGREED to site the bench at or near the wall on Cheapside, as identified. APPROVAL from Shropshire Council to be sought prior to siting. ACTION

iii) To CONSIDER Nominations for the Buckingham Palace Garden Party, 27<sup>th</sup> May 2020;

Councillors nominated The Mayor of Shifnal, Councillor Mr Robert Harrop and his Consort, Mrs M. Harrop. ACTION

 To REVIEW the Late Opening Hours of the Library and Implications for Staffing in view of Lone Working Policies;

Councillors heard that low visitor numbers to Shifnal Library after 5pm on Mondays and Wednesdays during the Winter months were not financially viable in terms of staffing and energy costs. The decision to hold a consultation with Library members to ascertain public support in the near future was AGREED. ACTION

v) To CONSIDER an UPDATE on the Local Economic Growth Strategy for Shifnal;

The Town Clerk to liaise with Gemma Davies, Shropshire Council Officer to arrange sessions/workshops for Shifnal Town Councillors. ACTION

vi) To CONSIDER proposals regarding a War Memorial and arrangements for the VE Day celebrations 8<sup>th</sup> May 2020 – Cllr Mick Treviss and Cllr Andrew Trickett;

It was AGREED to form a War Memorial Advisory Committee in order that full consideration was given to this proposal. Cllr Horne proposed that meetings of the Committee be held during the evening. Members of the advisory committee were AGREED as Cllr Horne, Cllr Treviss and Cllr Tricket, further consideration would be given to community members from the Memorial Bench crowd funding group and Royal British Legion.

vii) To CONSIDER altering the scheduled date for the Annual Town Meeting in view of the bank holiday on 8th May 2020;

Councillors AGREED to change the date of the Annual Town Meeting from Friday 8<sup>th</sup> May 2020 (VE Day Commemoration day) to the following week. The Town Clerk to confirm date and venue as soon as possible in order that the event can be suitably advertised. ACTION

viii) To CONSIDER proposed changes to the Speed Limit in Tong and associated consultation:

Councillors expressed SUPPORT for the proposed changes to the Speed Limit in Tong and associated consultation.

ix) To CONSIDER Shropshire Council communications regarding the publishing of Place Plans:

The Shropshire Council communications regarding the publishing of Place Plans was NOTED. However, Councillors sought assurances that recent changes made by Shifnal Town Council be included in future versions of the Place Plan and also that the Early Years Provision in Shifnal is made a priority. NOTED

x) To NOTE correspondence sent to Shropshire Council by Cllr Robert Harrop on behalf of Shifnal Town Council, regarding the state of highways in Shifnal.

Councillors NOTED a brief response from Steve Brown, Shropshire Council Officer, regarding the state of highways in Shifnal and the Capital Works Programme funding.

#### 186/19 Report from Advisory Committees

#### i) Car Parks

Mr Fennell-Fox informed Councillors that there will be a meeting of the Car Park Advisory Committee on 23<sup>rd</sup> January 2020. It was also NOTED that the lease of Aston Street Car Park is still required by Shropshire Council. ACTION

## ii) Christmas Lights

Cllr Killen informed Councillors that the support received from volunteers and Councillors had been much appreciated at November's Event. A total of £275 had been raised for Shifnal Shockers from the donation buckets and entry tickets sales on the night.

There will be a debrief meeting shortly with Christmas Lights Advisory Committee members when agreement to extend the display of motifs for the 2020 Event will be discussed and agreement letters to property owners can be sent out. Licensing issues will be resolved for the forthcoming event.

The Chair thanked Cllr Killen for her leadership of the Christmas Lights Advisory Committee and the success of 2019 Christmas Lights Event last November. ALL IN FAVOUR

#### iii) Plans

Despite assurances made by Peter Nutting, Shropshire Council Leader, via the Local Press regarding the proposed J3 M54 development, members were advised that the formal decision will be discussed at the Shropshire Council Cabinet meeting on 12th February 2020.

#### iv) Swimming Pool

Councillors RECEIVED a report from the meeting of the Advisory Committee held on 9<sup>th</sup> January 2020 and were informed that Shropshire Council have formally written to Landowners of the Haughton Road site requesting that the Community Land be transferred to Shifnal Town Council. Confirmation was sought by Councillor Tarran that the terms of the funding are in accordance with the Swimming Pool Advisory Committee's project plans. ACTION

#### v) Shifnal Shuttle

Councillors RECEIVED a report from the meeting of the Advisory Committee held on 8<sup>th</sup> January 2020. A Service Level Agreement between Shifnal Town Council, Shropshire Council and The Friendly Bus has been agreed for the next three years. Councillor Killen suggested that the forthcoming Spring Fling Event at Wheatfield Park could provide an excellent opportunity to publicise the Shifnal Shuttle Service.

Cllr Trickett asked that consideration be given to electric vehicles should the opportunity arise within the scheme.

#### 187/19 Health and Safety Concerns

- The poor state of the highways and pavements continue to be a concern for Councillors;
- ii) The block paving on Cheapside is sinking in parts and a member of the public has already been injured by tripping; ACTION
- iii) The wall damaged outside the War Memorial Club, Fiveways Island is still awaiting settlement by the vehicle's insurance company.

#### 188/19 Town Council Estate

i) To CONSIDER proposals regarding St. Andrew's Churchyard improvements.

Councillors AGREED to transfer £150 from the St. Andrew's Church budget to assist with the ongoing Churchyard improvements. Councillors were informed that a team of volunteers from St. Andrew's Church had recently been awarded a nationwide Bronze Award for St. Andrew's Churchyard being litter-free and tidy.

Cllr Turley suggested possible collaboration with Shropshire Wildlife Trust in respect of St. Andrew's Churchyard improvements and asked the Town Clerk to make contact with the Trust. ACTION

ii) To receive an update on the purchase of the Old Police Station Building and to AGREE the proposed transfer costs.

The Town Clerk informed Councillors that a completion date and exchange of contracts was proposed for 17th April 2020. The sum of £135,000 being the proposed transfer cost. These proposals were AGREED and the Town Clerk instructed to continue with the process.
