a) To CONSIDER verbal update on the Shropshire Local Plan

Cllr Moore commented that as the hearing had not yet occurred there was little to update other than submissions from other interested parties were as expected. It was noted that ABCA have lodged a submission.

Bruton Knowles will have an opportunity to speak at the hearing if required all other members of the Council or public would have an opportunity to view the proceedings but may not speak. Cllr Tarran will be in attendance to view only. Bruton Knowles will be requested by Cllr Moore, to provide a written report following this hearing. (ACTION)

The next round of hearings dealing with site specific matters is expected to be scheduled in late spring.

P407/22 To consider verbal update on the Empty Homes situation in Shifnal.

a) To DISCUSS current Empty Homes identified to Shropshire Council

A list of identified properties was NOTED by members with actions taken to date and a response received from Tracy Darke in relation to these matters was related by the Town Clerk.

The Town Clerk was asked to contact Emma Green, Planning Enforcement at Shropshire Council with a full list of identified properties and communications to date to request actions to be taken to rectify the long standing issues. (ACTION)

b) To CONSIDER verbal update on Market Place

Members NOTED the email response from Tracy Darke updating Shropshire Council actions and comments on the identified empty properties. The Town Clerk was asked to communicate with Tracy Darke and request an estimated completion date for matters relating to 16-18 Market Place, a confirmation when this has been completed and what follow up actions from building control would be taken in the interim. (see additional appendix A – confidential report)

The Town Clerk was asked to further communicate with Tracy Darke to clarify what actions were now to be taken in regard to 22 Market Place.

Cllr Haddon reiterated the health and safety concerns and continued eyesore in the newly refurbished town centre area. (see additional appendix A – confidential report)

c) To CONSIDER verbal update on the Barclays Bank Building, Shifnal

Members continued to raise concerns regarding the health and safety matters at this property. The Town Clerk was asked to contact building control to request immediate actions to remedy the concerns and copy local Shropshire Councillors into the communication. (ACTION) (see additional appendix A – confidential report)

Further to this Clir Cox agreed to arrange a meeting with the owner of the vacant Patons property to discuss the future options for this site. (ACTION)

P408/22 To CONSIDER verbal update on the Place Plan

Awaiting response from Shropshire Council.

The Town Clerk related a response received from both the Place Plan officer and Tracy Darke. The communications detailed that Shropshire Council officers are now developing the new IT programme and populating with the latest published versions of the Place Plans. They acknowledge significant delays due to officers being seconded to other priorities in the Council. Once this system is fully operating access will be allowed to all towns and parishes with the ability to update the plans independently.

At 18.11 hrs Standing Order 4D(xiii) was suspended to allow Cllr Tarran to speak from the Public Gallery. APPROVED

Clir Moore asked Clir Tarran for his comments on this matter. Clir Tarran commented that he was surprised that Shropshire Council were not giving a high priority to Place Plans as they were identified as important evidence for the Local Plan review. They were historically reviewed every 12 months but this system had stalled. An updated version had been submitted by Shifnal Town Council but it had not been accepted or published by Shropshire Council.

At 18.12 hrs Standing Order 4D(xiii) was reinstated to continue business. APPROVED

The Town Clerk was asked to distribute the latest draft version to members of the committee for further consideration at the next meeting. (ACTION)

At 18.13 hrs Clfr Horne left the room due to disclosed pecuniary interests.

P409/22 To CONSIDER verbal update on outstanding highways works on Haughton Road/Lane and S106 funded schemes

P410/22 To CONSIDER update on the storage facility at Shifnal Community Hub from Sara Jones (attached) and verbal update

Members considered the pre application advice given by the planning officer in regard to the proposed storage facility to the rear of the Community Hub. Members agreed that due to the notification of costs in both officer time and planning application process and the costs and difficulties in siting a suitable container for the purposes identified, the RECOMMENDATION to Council would be to not proceed with this action and seek alternative options for storage of the flood defence equipment.
