Public Session

2 members of the public were welcomed to speak by the Chairman.

The persons were concerned with the proposed planning application at Knowles Bank and highlighted serval matters that they considered were of note.

- The area is designated as Greenbelt and for agricultural and livestock usage.
- There are no mains power or water to the site and no easy access to provide such.
- There is a fuel line underneath the site of major importance that cannot be disturbed and causes safety concerns. Particularly as the installed hardstanding would now limit access to such.
- Large areas of hedgerow and natural environment would have to be destroyed to deliver the proposals.
- The current access road is maintained financially by the neighbouring residents and concerns that additional use would put undue wear and tear on such.
- Water and sewage management has highlighted concerns due to the lower lying proximity to Wesley Brook.

They further raised questions regarding regulatory services at Shropshire Council and the submission of comments on the portal which Cllr J. Moore responded to.

P648/22 To CONSIDER a report on outstanding highways works on Haughton Road/Lane and S106 funded schemes

Cllr J. Horne left the meeting at 18.51hrs

Members considered that there were no further updates on Haughton Rd outstanding works.

Members agreed that Cllr J. Moore, with committee members consultation, would formulate a letter to be sent to Tracy Darke at Shropshire Council and copied to Alex Edwards and Gemma Lawley to look for resolution and delivery of these schemes. ACTION

Members considered the walkways schemes that had been prepared by Alex Edwards and WSP on behalf of Shropshire Council and agreed the following.

- Old Smithfield Tunnel
 Members agreed to recommend to Council the support for this scheme as presented. APPROVED
- Church Street
 Members agreed to recommend to Council the support for this scheme as presented. APPROVED
- Bluebell Underpass
 Members agreed to recommend to Council the support for this scheme as presented. APPROVED
- Lawton Road East Members agreed to recommend to Council the support for this scheme as presented. APPROVED
- Lawton Road West
 Members agreed to recommend to Council the support for this scheme as presented. APPROVED
- Curriers Lane
 Members agreed to recommend to Council the support for this scheme
 as presented and additionally endorse the installation of 20mph speed
 restrictions in this area, APPROVED
- St Andrew's School/Park Lane
 Scheme on hold awaiting school development. NOTED

Five Ways/Innage Road

Members considered the in-depth reports provided on the modelling and studies undertaken and concurred with the recommendations of the officers in regard to Traffic Regulation Orders to resolve the noted issues.

Members agreed to recommend to Council the support for this scheme as presented and to instigate a Traffic Regulation Order to restrict parking between the hours of 7.30 hrs – 18.00hrs, Monday to Friday on Innage Road. APPROVED

Members further discussed possible solutions for the parking such as use of the War Memorial Club car park outside of opening hours. No recommendations were forthcoming.

S106 monies to the value of approx. £500,000 had been allocated to the Five Ways scheme but this was now unlikely to be required. The surplus will be redistributed towards any increased costs of the other walkways schemes noted. Any remaining funds may be considered for additional schemes that the Council consider are required in Shifnal.

Members agreed to recommend support for investigations to resolve the safety concerns and issues caused by the lack of a footpath at Netherwood, Haughton Road. APPROVED

Members noted the positive impact that the designated officer, Alex Edwards had delivered so far on these schemes.

Members also noted an update on the adoption of new developments by Shropshire Council and agreed these were very useful for information. The Town Clerk was requested to look for quarterly updates in the same regard. ACTION

P650/22 To CONSIDER Shropshire's draft Cycling and Walking Plan consultation which runs from 2nd May 2023 to 16th June 2023.

Members considered the documents as presented and agreed that there were no comments to be submitted as Shifnal was not identified in the plan. APPROVED.

The Town Clerk was requested to address an enquiry to the appropriate officers to detail why Shifnal had not been included in the above as a larger Market Town with identified S106 walkways schemes and an adopted Walkways scheme contained within the Shifnal Neighbourhood Plan. ACTION

P651/22 To CONSIDER the draft recommendations and consultation for the electoral review of Shropshire Council published by The Local Government Boundary Commission.

Members NOTED the consultation and documents as presented and agreed no further comments to be added at this time. APPROVED

P652/22 To CONSIDER the PC1-23 Infrastructure Levy and consultation closing on 9th June 2023 (attached).

Members considered the documents as presented and agreed to submit Cllr T. Tarran's prepared comments to the appropriate officer for inclusion in the NALC response to the consultation, as follows:-

- Seems an unduly complex process with major elements of how the scheme will operate in practice undecided, ill defined and unclear. Whereas now just have \$106/CIL, will now have \$106/Delivery Agreements/Provisional Levy/Final Levy/Integral Infrastructure/Levy Infrastructure/Infrastructure Delivery Strategy. Requires considerable additional support information on definitions, interpretations, process delivery which will place an undue burden on already stretched local authority planning and finance staff.
- Do not agree that payment on completion instead of when planning permission is granted, will still enable infrastructure to be provided when needed as claimed. It is not considered that the proposed local land charge registration will encourage developers to pay provisional levies. One of the objectives is to increase community involvement and control, yet delaying and giving payment to the discretion of the developer will be contrary to this objective as it is taking away any process control to local authorities and hence the community.
- Payment upon completion will encourage developers to delay completion to avoid payment, leaving unsightly uncompleted developments as a blot on the landscape.

- It is inappropriate to put the onus on local authorities to have to provide required infrastructure concurrently with development by having to use borrowing to fund such infrastructure during construction to ensure it is there when needed. This is putting a further financial and administrative burden on local authorities having to go through planning and financial hurdles to fund such infrastructure and seek replacement Levy funds at a much later stage.
- The Neighbourhood Share for town and parish councils should remain at
 no less than currently. Indeed, as an objective is to increase community
 involvement, there is a case for increasing the share given to these local
 councils who better know the needs of their local communities. A higher
 share for those councils who have produced a Neighbourhood Plan after
 full public consultation and referendum, should be retained.


