### 001/23 Fire Safety Announcement

This was given by the Chairman, Mayor Roger Cox.

#### 002/23 Public Session

Members of the public raised the following items:-

- With regard to Item 021/23 (iii) (d) Proposed Traffic Regulation Order Five Ways/Innage Road and parking restrictions. Two members of the public who reside in the locality in question raised their concerns regarding these proposals and strongly contested the parking restrictions.
- Mayor, Cllr Roger Cox thanked the residents for attending the meeting and expressing their views. The Mayor confirmed that Shifnal Town Council's role in this matter was one of consultee. Shropshire Council is the highways authority, and the final decision will lie with them. They have and will be carrying out the required surveys and consultation. Cllr Cox advised that Shifnal Town Councill would consider the residents comments and feedback for this agenda item.

- Cllr K. Turley stated that he had been in long discussions with Shropshire Council
  Highways Department regarding the issues in the Five Ways/Innage Road area and
  had requested Shropshire Council to look into the legalities of the grassed area on
  Innage Road.
- Clir J. Moore requested Clir Turley to raise the issue of the S106 works proposed for Haughton Road near to the new Medical Practice where currently there is an absence of any pedestrian crossing and gain some greater impetus relating to the proposed double roundabout and other safety measures. Clir Turley advised that he was liaising with Tracy Darke and would follow up. ACTION.
