P201/23 To CONSIDER a verbal update on the Shropshire Local Plan

Cllr J. Moore/Clir T. Tarran provided the following updates:-

- Bradford Estates solicitors have served notice to ask for a Judicial Review. They have requested a reply from Shropshire Council by the end of August.
- The challenge relates to the soundness of the Shropshire Local Plan and whether the council has fulfilled requests from the inspectors by providing the Black Country requirements on top of those identified for Shropshire.
- Shropshire Council have decided to reply that they are unable to meet this deadline. It is now up to the lawyers to either go ahead with the Judicial Review or wait and give them a further month.
- The inspectors comments are expected within the next 2-3 weeks.
- In terms of timetable they are realistically expecting Stage II hearing in the New Year.
- Concerns raised if Bradford Estates are successful and development allowed to progress that it would have an impact on Shifnal with a strain on infrastructure and services.
- Further update awaited.

- In discussion with Eddie West, Cllr T. Tarran confirmed he had requested clarity on the Shropshire Council project for electric development to meet requirements for existing and future development in the east of the town and how Shifnal Town Council can challenge Shropshire projects. o The topic of adoption of public realm area in the town is planned for a future meeting and Cllr R. Cox advised that Tracy Darke would be inviting Andy Wilde and Graham Downes to that session. In the meantime, Ffion Horton is actioned with circulating a map of Shropshire Council owned areas in the town so that STC can decide on which one's the Town Council wish to adopt.

Following the update from the Tracy Darke meeting, the committee discussed concerns regarding the nil progress of the double roundabout and pedestrian access to the medical centre once it opens to the public later this year.

During the discussion it was APPROVED for Cllr J. Horne to remain in the room.
