Greenspace Maintenance & Works

- Members CONSIDERED a report on a proposed refurbishment programme for the play areas at the Curriers Lane, Jubilee and Wheatfield parks from the CPO.
 - a) ES186/23 iii) Members PROPOSE to Full Council that more information has come to light that the floor may be repaired the committee would like to advise council to place the tender on hold until such time as we can consider a merit of a repair instead of wholesale replacement.

- b) Members AGREED that no further action be taken of the refurbishment of the Toddler Play Area at Wheatfield Park.
- c) Members AGREED that all play equipment that has failed BSEN1176 be checked with the councils insurance company and if uninsured be taken out of use – ACTION.
- d) Members AGREED that a working group be formed to discuss all parks and play equipment issues consisting of:- Cllr Cox, Cllr Moore, Cllr Haddon, Cllr Booker, The Estates Officer and one other Officer (tbc).


iii) To CONSIDER a report on the potential refurbishment project at Park Lane from the CPO.

Members AGREED that an order be placed with Dead Cert Pest Control for mole control at a cost of £585.00 (Budget Line 32 Open Space Maintenance (LGA 1894 s.8 (1)(i)) – ACTION.

 - a) Members AGREED that the headstones be jet washed annually - ACTION.



b) Members AGREED that the CPO arrange 4 nos. signs to be erected at the entrances to the War Memorial warning of the health and safety dangers of walking on the headstones – ACTION.
